**Discussion:** One member has expressed a concern about the profit and loss statement. The costs have risen dramatically in the last few months for both fuel and maintenance. Dan has been gathering detailed information on recent income and expenditures and will present a detailed report at the next board meeting.

**Discussion:** Chris reported that there were 51 responses to last months poll regarding where the club should be based. 35 favored having the club based in Corvallis, 12 in Albany and 4 in Independence.

**Discussion:** No report

Agenda Item: Revised Contract for Maintenance, Instruction and Fuel

**Discussion:** The discussion recommended some minor changes to the draft contracts that David had prepared. Most notable was the recommendation that all three contracts be combined into a single contract as it was felt that an FBO would be more likely to give larger discounts if they could count on OSFC as a major customer. After considerable discussion on each contract David has agreed to rewrite the contracts and combine them into a single contract and send it to the board for review.

### **Agenda Item:** Plane Captains

**Discussion:** John recommended that we have plane captains that are responsible to assure that each or the aircraft are being properly maintained. (See attached Resolution)

Due to the fact that David Hamby has taken on several other community service activities and has been appointed to several other boards he submitted his resignation as President of the Corporation. David agreed to remain on the board as the faculty advisor.

John moved and Dan seconded that Hal Kibby assume the office of President for the remainder of David's Term. The motion passed unanimously.

### 2.0 PLANE CAPTAINS

Plane Captains shall provide a monthly report to the Director of Maintenance on items of interest as specific by the Board. Plane Captains act only in an advisory capacity to the Director of Maintenance and to the Board.

### 2.0 PLANE CAPTAINS

2.1 There shall be a maximum of one (1) "Plane Captain" appointed by the Board of Directors for each aircraft owned by the OSFC, Inc. Plane Captains shall serve at the discretion of the Director of Maintenance and shall receive no compensation. Plane Captains shall provide a monthly report to the Director of Maintenance on items of interest as specific by the Board. Plane Captains act only in an advisory capacity to the Director of Maintenance and to the Board. (July 7, 2004)
