#### **Routine reports**

#### 1) Maintenance

#### a. July Expenses

- i. **N6045W**: 50 hour oil change (\$156.16), repair damage to pilot's door (\$7318.60, will be covered by insurance minus deductible), warranty credit for cracked heat baffles (-\$1262.50).
- ii. **N66083**: 100 hour inspection (\$1565.19), replace induction filter (\$209.20), reinstall AmSafe sensor module after required seven-year inspection & calibration (\$187.50), miscellaneous small stuff (\$293.56)

## b. Known Issues for August

i. **N73146**: A new engine has been installed, the cracked piece for the Power Flow exhaust system has been replaced, new heat baffles have (or soon will be) been installed, and the prop will be dynamically balanced sometime in the next few weeks as required by Power Flow to activate the warranty. The Lasar ignition system has been removed because the special magnetos, which have nearly 4000 hours on them, are no longer serviceable and replacements would cost about \$6,000. This did not seem worthwhile because the new engine came with new conventional magnetos. The total bill for all of this will be approximately \$35,000. The new engine will be broken in and flight-

- tested Tuesday morning, August 21. If all goes well it will be available for use that afternoon.
- ii. N66083: Will need an oil change late this month or early next month.
- iii. **N6045W**: The maker of the GATS fuel sampler has provided us with two actuators with longer pins so the fuel drain valve on the lower left side of the cowling can now be actuated without interference with the cowling. The little cup sampler that has been in use has been removed from the airplane.
- c. Motion Lindner, 2<sup>nd</sup> Parrott: "For Dalrymple to sell the old Lasar ignition system from N73146" Approved 5-0-0
