- 1) Board Resolution changes
  - a. Motion by John to strike Board Resolutions 4.6, which states "Incidents or accidents resulting in damage to aircraft, property, or person will result in the member at fault being responsible for up to \$1000. (Apr 1, 2007)", and to strike Rules for Flight Operations VI. 3., which states "Payment of the deductible, up to an amount set by the Board, is the responsibility of the member at fault."

- 2) Damage Liability
  - a. Motion by Jerry to change the language of Rules for Flight Operations II. 8. to read "Any member who damages corporate equipment will be responsible for the cost of repair for that equipment, up to the amount of the corporation's insurance deductible. If the board chooses not to file an insurance claim, the member will still be responsible for the amount of the deductible. In the event an insurance claim is denied due to the actions of the pilot, the member will be responsible for the full cost of repair."

  - c. Motion passes unanimously.

#### **New Business**
